Dear Anna,

Thank you for the opportunity to provide comments on the Storage Management Plan Draft Version 2. On behalf of the Chino Basin Water Bank, please see the four comments/questions below for the Watermaster's consideration.

- Based on our understand that the storage space used by the Parties is projected to reach 720 KAF and the combined use of managed storage by the Parties and Metropolitan's DYYP is projected to reach a maximum of about 790 KAF, how was the 800 KAF for the S&R Program derived?
- Why are S&R required to mitigate MPI as if the 800 KAF were fully used, when it potentially is not?
- How do the estimated net recharge of 2.41% and 1.5% as average storage used translate to the annual loss percentages?
- What process does Watermaster propose to adjust loss percentages in the future so that S&R Programs will have adequate time to prepare prior to changing conditions going into effect?
