(1:22:56) Mr. Kavounas introduced Mr. Yoo to give a report on item 1. He reported that Watermaster has received 2023 representation letters by all parties. Under item 3 he gave a recap of the December 5, 2022 Board Workshop and highlighted the increasing uncertainty in imported water supplies and the need for Watermaster to understand the effect of extreme hydrology on Chino Basin which will be a recommended task in the upcoming proposed budget. Mr. Kavounas also reminded the parties of the new Watermaster Orientation series beginning at 9:30 a.m. before every monthly Board meeting. Mr. Kavounas invited Ms. Moore to give an update on the 2022 Watermaster Annual Fundraiser (Little Heart Warriors), which was a huge success thanks to the Watermaster Stakeholders who supported. The \$10,000 goal was exceeded with a final tally of \$11,965 collected.
