



C. CHINO BASIN WATERMASTER ANNUAL AUDIT

Chino Basin Watermaster Annual Audit Performed by Mayer Hoffman McCann P.C.

Chair DeLoach noted there are parties who wish to pull the minutes and the financial reports and since no party wishes to pull item C, Chair DeLoach called for a motion.

Motion by Bowcock, second by Jeske, and by unanimous vote

Moved to approve Consent Calendar item C, as presented

Mr. Kinsey inquired about a portion of the minutes regarding the auction process. After discussion it was decided to make the recommended change to the minutes. Mr. Bowcock stated he was not in attendance at the January 21, 2010, meeting and noted Kevin Sage, his alternate, was at that meeting. Mr. Bowcock stated he has reviewed the minutes of January 21, 2010, and noted Kevin Sage informed him the minutes were incomplete and inaccurate and he will be voting no on the minutes. Mr. Bowcock stated at the joint meeting of the Appropriative and Non-Agricultural Pool the Non-Ag Pool pulled item IB 1 through 5 for reasons previously stated and will be voting no on the financial reports.

Motion by Kinsey, second by Crosley, and by unanimous vote – Non-Ag Pool voted no Moved to approve Consent Calendar item A as amended and item B, as presented

II. BUSINESS ITEM

A. CHINO BASIN WATERMASTER DRAFT POLICY MANUAL

Mr. Manning stated presentations have been made at the Pool meetings and each Pool has voted to approve the format only for the Watermaster Policy Manual and to allow more time for the members to review and comment on the Policy Manual. Mr. Manning gave background on the development of the Policy Manual. Mr. Manning stated the manual is an attempt to consolidate as many items that are contained within the Judgment, Peace Agreement, Peace II, Rules & Regulations, and adopted policies. This consolidated document will allow Watermaster to operate more efficiently. Mr. Jeske noted he attended the Agricultural Pool last week and that the Pool had some very good comments regarding the Policy Manual. They will be getting together to review the Policy Manual collectively and will be submitting comments at a later date. It was agreed the format is acceptable and this item needs to be placed on future agendas for discussion and/or review. A discussion regarding this matter ensued and it was noted any changes presented to Watermaster staff should go to Ken Manning from each of the Pool chairs.

A. WATERMASTER GENERAL LEGAL COUNSEL REPORT

1. Santa Ana Critical Habitat Comment Letter

Counsel Fife stated the Chino Basin Watermaster Santa Ana Critical Habitat comment letter that was submitted on February 8, 2010 is available on the back table. An extension of time to submit the comment letter was requested. However, the request was denied. Counsel Fife stated Watermaster has requested a public hearing be held on the critical habitat designation. The comment letter reflected off several other letters written by Western Municipal Water District, Riverside, SAWPA, and Inland Empire Utilities Agency; meaning Watermaster's comments are all consistent with theirs.

2. Chino Airport

Counsel Fife stated staff and counsel are continuing negotiations with the County and this will be an item for closed session at the Watermaster Board meeting next week.

B. FINANCIAL REPORT

1. Budget Update

Ms. Rojo stated Watermaster is currently starting the budget process

2. ECAC Update

Ms. Rojo stated the most current Estimated Cost at Completion Report (ECAC Report) which is a quarterly updated budget report is on the back table for review. Ms. Rojo noted this is an excellent report to track where projects are at on their progress financially and developmentally.

C. ENGINEERING REPORT

1. Recharge Master Plan Progress Report

Mr. Manning stated the reports regarding the Recharge Master Plan were given at the Pool meetings and since there was nothing new to report on Mr. Wildermuth was asked to forgo the meeting today. Mr. Manning noted there will be a workshop in March following the Watermaster Board meeting regarding the Recharge Master Plan.

D. CEO/STAFF REPORT

1. Legislative Update

Mr. Manning stated there is not a lot to report on legislatively. However, there are always discussions taking place regarding the budget.



SUMMARY

Issue - Record of cash disbursements for the month of January 2010.

Recommendation – Staff recommends the Cash Disbursements for January 2010 be received and filed as presented.

Fiscal Impact – Funds disbursed were included in the FY 2009-2010 Watermaster Budget.

BACKGROUND

A monthly cash disbursement report is provided to keep all members apprised of Watermaster expenditures.

DISCUSSION

Total cash disbursements during the month of January 2010 were \$2,494,704.61. The most significant expenditures during the month were City of Ontario in the amount of \$691,085.73, Aqua Capital Management LP in the amount of \$459,138.34, and Reliant Energy, Etiwanda in the amount of \$304,980.88.



SUMMARY

Recommendation – Staff recommends approval of the Intervention of Rafael Treto into the Agricultural Pool.

BACKGROUND

According to Paragraph 60 of the Judgment:

"[Any] person newly proposing to produce water from the Chino Basin may become a party to this Judgment upon filing a petition in intervention. Said intervention must be confirmed by order of this Court. Such intervener shall thereafter be a party bound by this judgment and entitled to the rights and privileges accorded under the Physical Solution herein, through the pool to which the Court shall assign such intervener."

According to Watermaster's Rules and Regulations section 2.27:

"Watermaster will receive and make recommendations regarding petitions for intervention and accumulate them for filing with the Court from time to time (Judgment paragraph. 60 and Order re Intervention Procedures, July 14, 1978.)"

Watermaster received a petition to Intervene into the Judgment from Rafael Treto dated December 10, 2009. Treto recently drilled a well on his property at 13160 Bon View Avenue in Ontario. The City does not have a potable water line in this area. The five-acre farm at this address has five cows, 12 horses, approximately two acres of grass, and a small house. The estimated annual water production is approximately ten acre-feet, and as such, the well will be metered.

Staff recommends approval of the intervention into the Agricultural Pool.

Water Supply & Drought Update


The Department of Water Resources (DWR) said it now expects to deliver 15% of requested supplies to State Water Project contractors this year, up from the 5% announced in December. The allocation could increase to the 35% to 45% range by late spring if average precipitation continues. DWR Director Mark Cowin said it is not likely that water supplies will return to normal anytime soon.

Reminding consumers that the region's water problems are not over despite the recent rains, the Metropolitan Water District has launched the latest in its series of radio advertisements asking Southern Californians to continue conserving water. Metropolitan is delivering its water-saving message in 10-second radio traffic sponsorships on more than 75 radio stations in English Spenish and Mandarin Chinaca throughout the Carlot Land

radio stations in English, Spanish and Mandarin Chinese throughout the Southland through March 12. "Winter storms may have left many of us with the misperception that Southern California's reservoirs are being filled this winter. But that isn't true," said Metropolitan General Manager Jeffrey Kightlinger.

MWD's WSAP Update

For the first seven months of performance under the MWD Water Supply Allocation Plan, IEUA's service area has received delivery of 42,496 AF, which is 6% under the Plan's expected delivery of 45,504 AF. This includes all expected DYY certifications for the second "call" year (May 2009—April 2010). Overall, the combined regional deliveries to MWD's service area are approximately 10% less than anticipated under the Plan.



IEUA Water Supply Programs

Imported Water Deliveries

For FY 2009/10, through January, IEUA and its member agencies have purchased 42,496 AF. Compared to last year at this point, IEUA and its member agencies had purchases 55,703 AF. This includes all expected DYY certifications for the second "call" year.

Dry Year Yield (DYY) Program

DYY participants have certified 33,047 AF (100% of their obligation of 33,000 AF) for the second DYY "call" year. All DYY participants are also on track to reduce their imported water purchases by 33,000 AF by the end of April 2010.

Chino Desalter Authority (CDA)

For the month of February, the two desalters produced 2,025 AF of water (of which 1,139 AF was delivered to IEUA retail agencies). The contracted entitlement is 24,600 AFY (but actual production is 25,000 to 26,000 AFY) and it is scheduled to be expanded to approximately 40,000 AFY by 2012, with the implementation of CDA Phase III.

Groundwater Recharge Program


In February 2010, with the rainfalls, approximately 2,800 AF of storm water was captured. In addition, approximately 200 AF of recycled water was recharged.

Victoria Basin





Quarterly Recycled Water Demand Management Meeting

The primary purpose of the meeting is to provide an open forum for discussion on how to communicate and schedule recycled water use during peak hours (mostly summer time) and what all of us collectively can do to efficiently manage water use.

The meeting is intended to be a discussion with the IEUA Member Agencies and high recycled water users, over 50 AF per year annual average recycled water consumption. It is highly encouraged for the Member Agencies to invite their respective high water users, such as school districts, park department supervisors and agricultural users, to attend this meeting. 


Recycled Water Usage: Feb 2010 Estimates

Conservation Program News

MWD Conservation Programs—Rebates

The residential SoCalWaterSmart Program is in various stages of marketing and outreach that include vendor field staff visiting retail sites to supply them with applications and program updates and providing outreach and training to landscape contractors in order to increase program activity. Overall, only 15% of the FY 2009-2010 budget has been expended. The commercial (CII) Save-A-Buck Program closed during the month of January and is no longer accepting new reservation requests. The vendor is currently processing the last remaining active reservations and all unused funding from expired reservations will be returned to the budget as a program surplus.

MWD Conservation Programs

MWD staff will be preparing a letter regarding the FY 2010-2011 conservation programs and budget that will be presented to the Board in April 2010. While the budget recommendation remains at \$19.1 for next year, there are still ongoing discussions with the member agencies regarding outstanding issues with MWD recommended program modifications that still need to be resolved. The next FY 2010-2011 conservation programs budget meeting is tentatively set for Thursday, March 11, 2011 with member agency conservation staff.

Legislation

February 19, 2010 was the deadline for 2010 California bill introductions. The following is a list of recently introduced bills:

SBX 77 (Steinburg) - 20% X 2020: technical clean-up legislation, no policy changes;

AB 1793 (Saldana) - Proposes to preclude Homeowners Associations from prohibiting synthetic turf;

AB 1774 (Saldana) - Recycled water: state agency landscape irrigation, would require divisions of the State to use recycled water when it is available, irrigation systems must meet Title 22. Updates the State greywater code that went into effect in January 2010, to be permanent in building code, must have permit, unless it is connected to a clothes washer and no pipes are touched;

<u>SB 918</u> (Pavley) – Water recycling: would require Department of Public Health to develop and adopt uniform water recycling criteria for indirect potable reuse, and investigate the feasibility of developing uniform water recycling for direct potable reuse consistent with a specified timeline.



<u>SB 565</u> (Pavley) – Delta water diversions – ensures the required permits and water accountability is in place for diversions taken off the Delta.

Conservation Program News (continued)

IEUA Regional Long-Term Water Use Efficiency Business Plan

A workgroup meeting was held on February 9, 2010 to review the status of the plan. The consultant presented her results of IEUA's existing and potential new regional programs evaluations, rankings, and cost-effectiveness. She presented the new IEUA specific program tracking module developed the by the Alliance for Water Efficiency and worked with the group to develop and select specific new programs for future implementation and incorporation into the final plan.

American Reinvestment and Recovery Act Funding for Appliance Rebates


The California State Energy Efficient Appliance Rebate Program will offer a \$100 rebate on high efficiency washing machines with a water factor of 6.0 or less. This rebate is in addition to incentives offered by MWD, Southern California Edison, and the Gas Company. The rebate program is tentatively scheduled to open from April 22, 2010 – May 23, 2010 and will either be extended beyond this period or offered again later in the year if all funding is not expended. Participants will have 30 days from the date of purchase to submit applications. Marketing is scheduled to begin in March.

DWR Water Use Efficiency Listening Session

The California Department of Water Resources (DWR) has scheduled two Public Listening Sessions regarding implementation of two specific projects as part of the 2009 Water Conservation Act (Senate Bill X 7 7). Based on deliverable due dates these first Listening Sessions will focus on the Urban Baseline Technical Methodologies and a Method for Calculating Urban Water Use Reduction Targets requirements of the Water Conservation Act of 2009. Those sessions are as follows:

March 8, 2010 - Sacramento, CA March 10, 2010 - Los Angeles, CA 9:00 am—3:00 pm (tentatively)

IEUA Monthly Water Use Report - March 2010

The purpose of this report is to track IEUA and its member agencies water use on a monthly basis. Over the next 12 months, tracking water use will be essential to complying with the Drought Allocation Plan, Dry Year Yield Program and Tier I/Tier II limit. Below is a summary of current water use and programs that IEUA and its member agencies are participating in. Attached are several tables and graphs representing overall water use and imported water purchases.

THE FIRST 6 MONTHS OF FY 09/10 SAW MORE RECYCLED WIATIER RECHARGED THAN ANY FULL YEAR IN IEUA'S HISTORY!

Imported Water Deliveries

For the month of February, IEUA purchased 673 acre feet (AF) of Tier I water. This gives IEUA a total of 3,441 AF purchased in calendar year 2010. IEUA is still 6% under the expected deliveries, through February, for MWD's Water Supply Allocation Plan.

Dry Year Yield (DYY) Program

IEUA DYY participants have certified 31,047 AF (100% of IEUA's obligation of 31,000 AF).

Recycled Water Program

During the month of February, IEUA sold approximately 500 AF (333 AF = direct sales, 167 AF = recharge). As of January 2010, IEUA has connected 32,216 AF of recycled water demand. IEUA is implementing a 3-Year Business Plan that will increase recycled water connected capacity to 50,000 AFY by 2010.

Chino Desalter Authority (CDA)






In February 2010, IEUA recharged approximately 3,000 AF of water (200 AF of recycled water and approximately 2,800 AF of stormwater).



Note. Given the unique events of the past month, this report will address the issues somewhat differently.

Gridlock – Multiple Levels and Many Meanings. Snow (Massive Amounts of It), Health Care and Climate Change, Salazar Budget and Feinstein Amendment

Snow. Gridlock. Washington got clobbered with back-to-back snow storms. The City and region was paralyzed for days. Got 26" where we live. Many in the region received more. More than a million were without power at one point. Roads impassable. Subway not running. Congress shut down. Government, schools and businesses closed. One person said, "Washington got more snow than Buffalo." Last year, the Washington area had 3" of snow.

This year, close to 60". As the end of the month is upon us, we still have snow on the ground.

Senate Cloture Votes – Health Care, Climate Change, Jobs Bill. Gridlock has the Senate tied up in knots and it cannot conduct business on much of anything. In 2009, the first session of the 111th Congress, there were 112 Cloture Votes (60 Members of the Senate have to vote to proceed on the pending business). This was an all-time record – shattering the previous one from a decade and a half ago. In January and February of 2010, there were already more than 40 such votes. However, a week ago, a bi-partisan vote allowed the Jobs bill to move. The Senate is unable to complete action on any of its obligations. This means that action on health care, climate change, energy – and even the Jobs bill – is subject to unending delay right now. There is open talk of various procedural means of moving forward or even advancing a new package of Senate Rules which would eliminate or curtail the use of the filibuster.

Salazar Budget – Bureau of Reclamation. In early February, the Bureau of Reclamation's proposed budget for the Department of the Interior and the Bureau of Reclamation was submitted to Congress shortly after President Obama delivered his State of the Union speech. It proposed \$29 million for Title XVI (for all 17 Western States) in the middle of severe drought. It was not well-received, by the water community, by Congress in general and/or by key congressional leaders such as Rep. Grace Napolitano, Chair, Subcommittee on Water and Power. Salazar has rejected her recommendations to "stretch" water, but steadfastly fails to offer an alternative plan.

Feinstein Amendment. Senator Feinstein issued a statement announcing that she was offering an amendment to the Jobs bill in the Senate to set aside ESA to allow water to be pumped to the Valley and to the Westlands Water District. It creates a firestorm within the State, among and between water users, Indian Tribes, environmentalists and fishing interests. According to one member, the Feinstein amendment has three fundamental flaws. First, it sets a precedent for Congress intervening in ESA decisions. Second, it overturns an active court case, something even Congress contemplates with great reluctance. And third, the Interior Department and Bureau of Reclamation are usurping State Water Rights – which has significant political implications throughout the 17 Western States. Three Cabinet Members – Commerce, USDA and DOI – met with Feinstein, Boxer and a group of members from up and down the State, including Chairwoman Napolitano (who is recommending that a major investment in Title XVI be made with the goal of expanding – or stretching – California's water supply by 1 MAF through recycling). Those talks began at the end of February and are expected to continue into early March.

For now, gridlock, in one form or another, is all around us. There was "winner" amidst all this – tele-commuting. Laptops became indispensable. Lots of work got done, but few were in the office to do it.

Drought Conditions and Water Supplies. The series of storms have begun to make a difference in California – and throughout the West. Last month I reported that drought was "lessening."

The trend is continuing. The USDA-NOAA Drought Monitor shows Southern California "free of drought" (at this moment) for the first time in well over a year, maybe two. This is both encouraging and deceptive. According to State DWR, at month's end, anticipated water deliveries were increased from 5-15% – which would be the lowest allocation in history. The new DWR Director, Mark Cowin, said, "despite a relatively wet winter, our reservoir storage levels remain low....after three years of drought conditions and mandated pumping restrictions..." Cowin went to say that Oroville, even with the wet year, is only at 54% of average storage And he added, significantly, "another hydrologic condition affecting the allocation is the condition of the watershed. After three years of drought, the watershed is dry and will likely absorb more of the snowpack." In short, storms this Winter are helping, but the State has a long way to go.

New Bill Introductions

Approximately 600 bills were introduced for the 2010 legislative session.

Many bills address Delta conveyance options, the Delta Stewardship Council, the Delta Plan and the BDCP. If the November water bond fails passage or is delayed, the Council and those developing the BDCP will be seeking funding from state and federal sources to continue their work on Delta conveyance and Delta habitat restoration.

There are also a number of bills intended to encourage the use of recycled water and development of local water supply. No bills were introduced concerning water softeners, or attempting to change IEUA sponsored bill AB 1366 (Feuer). A bill list is attached.

Budget Update

January revenue came in about \$1.2 billion higher than projected. The uptick marked the third time in the past four months that the revenue number has come in higher than projected. This has some budget staff projecting that between \$2 billion to \$5 billion may be coming off the expected \$20 million deficit through June 2011. While budget subcommittees have already cut approximately \$2 billion in various programs, it appears likely that lawmakers will wait until after the May Revise to consider cuts to education and health and human services

February Monthly Legislative Update

February was a difficult month in Washington, DC. A series of terrible snowstorms caused the federal government to close for several days and interrupted work on Capitol Hill during the second week of the month. With the following week being the President's Day recess week, Congress was only in session for two weeks of the month. During the short time Congress was in session, it did not accomplishing very much. Continued work on job creation measures has not yielded any results, and the healthcare bill remains stalled.

All of us at IFS have also been snowed under by appropriations forms and whitepapers! We spent all month working on meeting the deadlines set by the Members of the House and Senate to ensure that your requests were timely, accurate and compelling. Now that most of the deadlines have passed, we will be on standby in case any staff contact us with follow up questions about your requests. We had a series of great meetings while Martha was in town during ACWA the final week of the month.

Jobless Benefits Legislation

Last week the House passed a short-term extension of economic safety net programs and other policies that expired on Sunday, February 28. The bill (HR 4691) would extend expanded unemployment benefits through April 5th and other programs, including health insurance subsidies for the jobless, highway funding, prevention of Medicare payment cuts for doctors and laws governing satellite television transmissions through March 28.

This week, the Senate will consider a bill similar to the House bill which will also include longer-term extensions of all of expiring provisions, along with some tax provisions that lapsed at the end of the year. This bill is in addition to the \$15 billion "jobs" bill (HR 2847) that the Senate passed last week which included 1.) a payroll tax break 2.) an expansion of the Build America Bonds program of tax-credit bonds for state and local infrastructure projects 3.) an expiring extension through this year for higher expensing limits for small businesses included in last year's stimulus bill and 4.) the controversial extension of highway (SAFETEA-LU) benefits. (See below for more on that legislation.)

The bill, which will cost about \$150 billion, will extend expiring unemployment benefits, COBRA healthcare subsidies, dozens of lapsed tax breaks for businesses, farm disaster aid and

other provisions through the end of the year. The big problem that the bill faces is that the cost is not off-set. Many Senators will have heart burn over this fact, and failure to properly off-set the bill's costs will cause terrible problems in the House of Representatives.

Oberstar Reaches Deal on Jobs Bill

The \$15 billion "jobs" bill (HR 2847) passed by the Senate last week inadvertently gave four states over half of the money allotted in the bill and 22 states none. Of course, once House and Senate legislators realized the result of the formula, there were many objections. Due to the uproar, the House did not pass the bill and the Senate adjourned without passing another extension of SAFETEA-LU which means that the current highway funding law expired last night. The House and Senate plan to fix this quickly but workers will start receiving furloughs on Tuesday.

House Transportation and Infrastructure Committee Chairman James Oberstar (D-MN) announced late last week that House and Senate leaders have reached an agreement and he will halt his objections to the House's proceeding with the Senate-passed "jobs bill", HR 2847. Mr. Oberstar had opposed the Senate bill because of the way it handles two programs formerly earmarked by the SAFETEA-LU law. Oberstar would amend the bill to include surface transportation extension to distribute those programs via the formula by which the comprehensive amount of formula funding is distributed to states. Oberstar's amendment raises hopes that the House will pass the Senate bill (HR 2847) and the coming shutdown of the Highway Trust Fund and furlough of many Department of Transportation employees could be ended by midweek.

Healthcare Overhaul

With last week's Healthcare Summit over, this week Congressional leaders will begin efforts to pass a healthcare overhaul bill. House Democrats expect President Obama to make some concessions to Republicans and send a revised healthcare proposal to the Hill. The President last week sent Members a package of changes to the bill that the Senate passed Christmas Eve. (Please see Administration section below.)

The most-discussed option is for the House and Senate to pass a measure through the budget reconciliation process that would make tweaks to the Senate bill but the House also must approve the Senate-passed bill. But one of the newest ideas on the table is for the House to take up legislation that would allow Medicare to negotiate prescription drug prices. Other single-issue bills the House could take up include closing the coverage gap in the Medicare prescription drug benefit, allowing people to stay on their parents' insurance until their mid-20s, guaranteeing people do not lose their health insurance if they lose their jobs, stopping insurers from dropping people who get sick and potentially prohibiting insurers from denying coverage based on pre-existing conditions.

House Appropriations Committee Leadership Changes

As you may know, the House Appropriations Committee lost one of its longest serving members and the Chairman of the House Defense Appropriations Subcommittee, John P. "Jack" Murtha (D-PA). Congressman Murtha died two weeks ago after complications from gall bladder surgery.

House leaders are postponing formal action to replace Mr. Murtha with a new Chairman until after his memorial service is held this week. Traditionally, House Appropriations Committee Chairmen are selected for their position by seniority on each subcommittee, rather than full committee seniority. As such, Congressman Norm Dicks (D-WA) will become the new Defense Appropriations Chairman to replace Mr. Murtha and Congressman Jim Moran (D-VA) will move up to take the Interior-Environment Chairmanship that Mr. Dicks vacates.

Please find attached the status report from The Dolphin Group for the month of February 2010.

As it is every year, February is the month to consider and submit new bills for the upcoming legislative session. Despite ongoing budgetary problems and a struggling economy, the California Assembly and Senate still managed to introduce approximately 1,600 new bills prior to the February 19 deadline. While the budget situation will continue to dominate the conversation, policy hearings on many of these measures will begin in earnest in mid-March.

On the regulatory front, the CPUC is rapidly moving to open a narrow reenrollment of direct access for utility customers, which must be completed in just two months. They are also about to begin the implementation of Assembly Bill 920 (Huffman – 2009), which will allow customers to be compensated for net-energy metered accounts that produce excess electricity. Efforts also continue to move forward to implement SB 32.

Direct Access to Have Limited Reopening

Beginning with deregulation in 1996, electricity customers were offered the opportunity to contract with third parties for the supply of electricity, a process called direct access (DA). During the Energy Crisis of 2000-01, as wholesale prices rose significantly, most DA customers returned to bundled service with their utility. Additionally, the Legislature passed a law suspending all new DA contracts, although the CPUC took months to implement the suspension. All customers who had a DA contract before September 20, 2001 are considered "grandfathered" and permitted, every three years, to opt back into direct access contracts if they choose.

In 2009, Governor Schwarzenegger signed Senate Bill 695 into law, which permitted a gradual reopening of the DA market, among other rate changes permitted by the measure. As a result, there are now essentially two types of potential DA accounts, those that fall under the previous grandfather clause, and those who elect to enroll under this limited reopening. Under the provisions of this measure, the utilities are not permitted to allow the total amount of DA customer usage to exceed their highest enrollment after April 1, 1998.

A draft decision was issued in mid-February which provided some boundaries regarding this new enrollment. Under the draft decision, 3,946 GWh of new DA load will be authorized. Currently, SCE has 7,764 GWh of direct access customers.

50% of this cap will be available in year 1 (2010). The effective date of the new program will be April 11, 2010 for the first phase of 50% enrollment, providing scarce time to opt into the DA program. In the following years, 20% will be available in 2011 and 2012, and the remaining 10% in 2013.

Existing "switching rules" (adopted in 2003 by the CPUC to govern over movements between Direct Access and bundles service) will remain in effect and govern these new DA customers.

The CPUC will be voting to approve the draft decision on March 11, 2010.

AB 920 Implementation Set to Begin

Assembly 920 (Huffman – 2009), signed into law last year, requires a utility (PG&E or SCE) to offer compensation for excess energy produced under net-metering; under previous rules, all

excess energy is kept by the utility for free. However, AB 920 does not specify how this compensation will be calculated, other than bill credits should be available. The level and manner of the credits and/or monetary compensation will need to be determined by the California Public Utilities Commission

Generally, the options are generation value (the commodity price of the energy), full-retail value, the market price referent(the price paid for renewable power under the feed-in tariff) or some other composite price. It seems apparent that the utilities will likely ask for the generation price, which is the lowest among the choices. The implementation process is just beginning, and a decision is not expected until later this year by the Public Utilities Commission. The CPUC is expected to issue a ruling soon to begin this implementation.

Although it becomes effective in 2011, because a net-metering customer may have a retroactive 12-month "true-up" during 2011, it is possible for the customer to receive compensation for net-exports created in 2010.

SB 32 Implementation Preparing

Although the statue has been in effect for nearly two months, the CPUC is expected to belatedly begin implementing Senate Bill 32 (Negrete-McLeod – 2009) by mid-March. The CPUC has been finishing up on a closely-related proceeding related to feed-in tariffs as large as 10 MW that is intended to complement FiT programs such as SB 32, which permit projects up to 3 MW.

DGI, IEUA and other partners in passage of SB 32 last year continue to work with the CPUC, Governor's office and the utilities to move forward to reestablish the FiT price as dictated by SB 32. Final implementation and a readjusted price is expected in mid-2010.

BUDGET WOES CONTINUE

In late February, California lawmakers began voting on a Democratic package of bills aimed at trimming the state's \$20 billion deficit by about \$5 billion.

The Assembly and Senate began voting on February 22 on legislation that would reduce some government services and the state employee payroll. Among other provisions, the package would change the way the state allocates the taxes it collects on gasoline. It also would give local governments more authority to raise taxes and would allow the state to enforce tax collections from Internet retailers.

It is unclear if Gov. Schwarzenegger would sign the whole package, which is being passed without Republican support.

Forecasts of California's General Fund revenues and expenditures shows that the state must address a General Fund budget problem of \$20.7 billion between now and the time the Legislature enacts a 2010–11 state budget plan in June. The budget problem consists of a \$6.3

billion projected deficit for 2009-10 and a \$14.4 billion gap between projected revenues and spending in 2010–11.

Forecasts show that operating deficits after 2010-11 will be around \$20 billion each year. The forecasted gap between revenues and expenditures is the greatest—\$23 billion—in 2012-13 (the year when the state must pay back its loan from local governments pursuant to Proposition 1A of 2004).

LEGISLATURE COMPLETES BILL INTRODUCTIONS

February 19th was the deadline for legislators to introduce new legislation for the 2nd year of the 2009-2010 legislative session. Despite a crippling budget situation and a \$20 billion deficit, legislators still managed to introduce more 1,500 additional bills for consideration. Nearly 1,000 measures were introduced in the last two days alone.

DGI has initially indentified the following measures for tracking in the current session. Many of these are "spot bills", which do not contain substantial changes to statutory language, but serve as potential placeholders for later amendments that may affect code sections of interest to the basin and Coalition.

DGI staff will work with IEUA to narrow this list over the coming weeks in order to focus on key measures of significance to the basin and Coalition.



Old water deals haunt Mentone

Redlands' purchases of companies adds leverage in annexation efforts

The history of Redlands' involvement in how Mentone residents receive water and sewer services is a complex and touchy subject.

In 1997, Redlands voters passed Measure U. The measure requires all noncity residents receiving water and sewer services from Redlands to sign an agreement saying they would not protest if Redlands wanted to annex the area.

Through annexation, Redlands would incorporate parts or all of Mentone into the city.

"Basically people in Mentone feel hijacked by the city of Redlands," said Cheryl Tubbs, a Mentone resident and water services consultant who served on the San Bernardino Valley Water Conservation District board for 16 years.

The problem for Mentone residents, she said, is both Redlands and San Bernardino County charge for services. And the possibility of annexation causes blood to rise as much as getting the services from Redlands.

"It's the higher cost and piece by piece they're

annexing Mentone into Redlands, and Mentone does not want to be part of Redlands," she said.

Redlands Water Resources Manager Chris Diggs said Mentone residents benefit from Redlands' presence there.

"There is no other water provider out there so we're not trying to be a big bully," he said.

Parts of Mentone are annexed if they are adjacent to Redlands, he said. Mentone and the Crafton area are considered in Redlands' sphere, so the city provides water and sewer services if residents request it, Diggs said.

He said Redlands charges Mentone residents the same as anyone else - they just have to pay a fee to the county's Local Agency Formation Commission, which must approve how they get services.

"They are all the standard fees any other customer would have," he said.

History

The history of water supply in Mentone goes back to the 1800s. At one time, Mentone had several water companies. Mentone Water Co., Mentone Domestic Water Co., Greenspot Water Co., and Redlands Zanja were a few companies offering water.

In 1926, Redlands bought water rights in Mill Creek. A few years later, Redlands bought

Mentone Domestic Water Co. has provided water to Mentone residents since 1900.

W.J. Tench dug the first well himself at what is now Mentone Boulevard and Agate Avenue. His company supplied water to residents and orange growers, and to the railroad for steam engines. His system covered a good chunk of Mentone, west of Agate and down to Wabash Avenue.

His descendent, William B. Tench, dug another well in 1972 and continued to sell water to residents of the Crafton and Mentone areas. His son. Duwayne Tench, inherited the company at his father's death in 1975, and sold it to the city of Redlands in 1978.

"What kind of angered old-timers up here was he didn't consult anyone," said George Everett, a minister who has lived in Mentone about 40 years. "There was a group that would have bought it for sure."

That began fueling Mentone residents' anger with Redlands, he said.

"But it was not Redlands' fault," Everett said. "They had the opportunity, and probably had to spend lot of money maintaining those old lines Tench put in 70, 80 years ago."

The city did have to replace pipes in what Redlands designated the Tench area, Diggs said. A few longtime residents and business owners declined to comment on Redlands' supplying water and sewer, saying they did not want to cause more friction.

Ernie Givens, president of the Mentone Area Community Association, said there used to be a few water districts in Mentone.

"There were all these people who owned them, and they got old," he said. "(They said) 'Well, w e'll sell out,' and who's the prime candidate? Redlands."

He said costs have gone up because water is treated and sent back.

"Now it's a \$12 household, and then you have your water use you pay for, so right off the top it costs \$12 more for anyone outside of Redlands city limits," he said.

"The Mentone people are saying Redlands is taking our water and shipping it back to them, which is true, but they were the only ones stepping up to the plate when Tench and others wanted to sell," he said.

"What can you do? They have control."

Getting services

Most of Mentone is on septic systems, and people can get a septic tank if the property is more than half an acre, Tubbs said. If a property owner not contiguous to Redlands wants sewer

services, the owner must pay to be connected to the line, she said.

"So property owners feel it's unfair because they're in the jurisdiction of the county for water rights," she said.

Many cities provide services outside their boundaries, but Redlands and the county seem to double up in Mentone, she said.

"There is a problem in both the city and county requiring water and sewer services to be provided and people are paying twice," she said.

"To me that's the biggest part of the story between the county and city, one hand does not know what the other is doing," she said.

Land-use entitlement is through the county and water and sewer are through the city, she said.

She said Redlands' and the county's involvement in Mentone affects development because of the cost of getting services.

"Getting everybody in the same room is what needs to be done so business owners don't get hijacked on costs," she said.

Diggs said Mentone is broken into service areas so there is not duplication. Residents must go through the county for approval to receive services, he said.

"Once they get approval from LAFCO and the

(city) council approves, we can offer them water," he said.

He said residents do not need to receive services from Redlands.

"They can drill a well or they can drill a septic system - it depends on the size of the lot or how close it is to existing sewer lines," he said. "If so they need approval by the local board."

He said Redlands needs county approval to offer services because areas like Mentone are in the county's jurisdiction.

Because the process of getting services is so complicated, city employees "walk them through the process and hold their hand," said city program manager Ross Wittman.

Whatever the case, the pro-annexation agreement is now part of Redlands' municipal code, Diggs said.

"We don't have the power to change that," he

Tubbs said people associate being in the county with being more rural. Redlands annexing Mentone might diminish that character, some residents might argue.

"Back in the '70s it was quite a community - we had a chamber, Rotary club - then it all died away," Everett said.

Bottleneck at Delta must be opened

Heading into 2010, one thing is certain about the water situation for the Inland Valley and all of Southern California:

No matter how much it rains, the water shortage facing the region and much of the state will not be over. A tightening bottleneck exists at the hub of the statewide water system - Northern California's Sacramento-San Joaquin Delta. The problem is akin to a freeway with most of its lanes closed at rush hour. This statewide problem has only been getting worse in recent years. And it severely compromises Southern California's ability to take advantage of a wet winter and replenish our water storage network.

Local and regional water districts have taken aggressive actions to lower demand and to fairly distribute available supplies. Gov. Arnold Schwarzenegger and the state Legislature have approved sweeping legislation to address the Delta crisis and statewide water issues.

What is needed now is continued water efficiency in and around our homes and businesses and continued action by the Obama administration in Washington to address the Delta bottleneck, both short- and long-term. The interim federal action plan announced

Tuesday shows promise.

Eastern Los Angeles County and western San Bernardino County rely on supplies that come across the Delta, transported via the aqueduct system of the State Water Project to replenish the groundwater basins. The Metropolitan Water District of Southern California is in charge of importing this supply, as well as water from the Colorado River, for six counties with 19 million residents.

As a sign of the severity of the problem, the state has notified Metropolitan that the region's allocation of Northern California supplies through the Delta may be only 5 percent of a full, traditional delivery. This is the lowest initial prediction of available state project supplies in the history of this project.

It's still December. Much can change between now and the end of the rainy season. In April, Metropolitan will decide the extent of necessary mandatory conservation for the coming year needed by water districts in the Inland Valley and throughout the district's service area. This decision will signal the severity of any shortage.

The best Metropolitan can realistically hope for is an average supply of water from Northern California. Yet, because of restrictions in the Delta, it would take a very wet winter to provide an average amount of water supply. An average rain year would provide a below-average supply, and so on. Only so much supply can pass through the Delta bottleneck until something is done.

The Delta is where the rivers of the Sierra Nevada merge before heading west into San Francisco Bay. It was once one of nature's great mixing zones, where tidal pulses from the Bay and river water would mingle in wetlands that provided food and habitat to countless fish and bird species.

Today's Delta is in an ecological free-fall. Ninety-five percent of the original wetlands are gone because of levees. Ninety-five percent of aquatic life in the Delta does not belong there, with various invasive species dominating the food chain.

Wastewater discharges by local communities may be contributing to the problem as well. So are water diversions both within and upstream of the Delta.

The outdated and inaccurate perception held by many is that Southern California drains the North's water. In reality, Southern California on average has diverted only 4 percent of the runoff from this massive Delta watershed. Four percent. This region, however, has been uniquely vulnerable to the problems in the Delta because of the regulatory response to the broader crisis in the ecosystem.

The State Water Project - along with the similar federal delivery system that serves the San Joaquin Valley, the Central Valley Project - have been the focus of enforcement actions under the state and federal endangered species acts. They are the two large "knobs" in a very complicated ecosystem that invite adjustment.

New "biological opinions" to address various fish species (smelt, salmon, and sturgeon) have restricted the flow of supplies across the Delta to the aqueduct facilities in the southern Delta.

In dry years, the bottleneck isn't the primary problem. When traffic is light, a one-lane freeway can handle the load. It will be a wet winter - either this one or some year in the future - when the bottleneck will create its biggest impact. As much as 200 billion gallons of water that Metropolitan could normally count on will not be delivered because of these restrictions. As a comparison, that is roughly enough water to refill the now half-empty Diamond Valley Lake Reservoir in southwest Riverside County and have about 60 billion gallons left over to store somewhere else.

Short term, the Obama administration can build on the interim federal action plan for the Delta to help address this bottleneck in two important ways. There is considerable flexibility to operate the Delta water projects within the existing restrictions that federal agencies can exercise. There are also a number of experimental projects that await federal approval that should protect fisheries while allowing more pumping.

Long term, the Delta needs a different system to convey water that can operate in harmony with a recovering ecosystem. State agencies, water districts and key environmental groups have

taken the lead in drafting a comprehensive solution through a process called the Bay Delta Conservation Plan. Ultimately, federal wildlife agencies must approve and implement this plan. Federal leadership and ownership of this process will be absolutely necessary.

Next year, Southern California's water supplies will depend on how much it rains and snows, particularly in Northern California; how the federal government regulates the Delta; and how much water is available from the Colorado River, which has its own set of legal challenges and supply limitations.

Metropolitan has reduced by nearly 20 percent the imported supplies it provided to communities and farmers compared to a few years ago. The district has also drawn down about half of its reserves in the process. This pattern is not sustainable; it cannot last indefinitely.

A combination of actions - expanding conservation, increasing local supplies through recycling and desalination and addressing the Delta bottleneck - can put the state and region on a much more reliable path in the years ahead.

SAN ANTONIO HEIGHTS - A community resident's effort to determine what a fair price would be for water stock from San Antonio Water Company led him to an unusual destination - eBay.

Bob Taylor decided to put a quarter share on the online auction and shopping Web site because he was unsure what to sell it for

"We wanted to sell it at a fair price and it seemed like the best way we could have set a price," Taylor said. "I never would have known if it was too high or too low."

Charles Moorrees, water company general manager, said he was surprised to hear that the share was put on eBay, but added there were no rules against the action.

"It's their personal property," Moorrees said. "It's like their IBM stock. They can take off with it."

San Antonio Water in October held a water stock auction for delinquent shares of water. Monte Vista Water Company in Montclair outbid San Antonio Heights residents and wound up with four shares of stock for \$264,000.

Monte Vista Water's acquisition upset many residents who now can't get water to their property unless they own a share of San Antonio Water.

"I think people should know what's available and what other people are willing to pay for it," Taylor said. "I really prefer some residents to buy it."

Though heavy rains have moistened Southern California's dry soil, it hasn't lessened the state's dehydrated condition or provided any long-term answers to its water woes.

"We're still in a drought," said Debby Figoni, conservation specialist/education coordinator for the Chino Basin Water Conservation District (CBWCD).

"Cutting back on water usage will conserve our resources, be better for the environment and benefit everyone. So many people want to conserve - they just don't know how," she said.

The CBWCD is taking people from just wanting to conserve water to conserving water - by showing them how.

Based in Montclair, the CBWCD is a public agency serving Chino, Montclair and parts of Chino Hills, Upland, Ontario and Rancho Cucamonga.

Its mission is to protect the Chino Groundwater Basin, educate individuals and organizations in water conservation and promote the efficient use of water resources. In helping to meet its goal, the CBWCD has started free, user-friendly workshops that offer the public useful tips on being water wise. The workshops are open to anyone.

"Water Wise Gardening (The Basics) is like Water Wise Landscaping 101," Figoni said. "It sets a foundation and is a gateway to other workshops."

Those who attend Water Wise Gardening (The Basics) will leave with the knowledge and ability to go home and make changes that will have a positive impact on their water consumption.

The workshops are on site in the district's conference room and includes an informative tour of its beautifully maintained garden that's filled with many examples of drought-tolerant plants, ground cover and foliage.

workshop and there is always plenty of printed material available at the CBWCD office on water-saving tips, water- wise nurseries and a plant list.

"About 60 percent of the water the typical household uses comes from outside irrigation," Figoni said. "We can teach people how to remove their water-guzzling lawns and replace them with water wise wonderlands."

Attending the workshops will teach participants how to implement drought-tolerant landscaping that can reduce water consumption up to 40 percent.

Water wise gardening is also economical, Figoni said. "If you put in the right plants, the need and cost for pesticides and fertilizer goes way down," she said. "Everything will grow more naturally in the right environment."

Even if people want to keep their turf lawns, workshops can show them how to reduce their water consumption. "Just switching the sprinkler head makes a huge difference," she said.

Many people are hesitant to trade in their lush green because they associate "drought-tolerant" with succulents and cactus, but there are many types of ground cover, flowering plants and fragrant shrubs that make any landscape lively and interesting.

"Landscaping can be overwhelming. I try and make it easy to understand and clear," said

Water Wise workshop instructor Juan Zamora. "I want to show how to use water wisely and have a lot of fun."

Zamora's teaching style includes lots of showand-tell paired with hands-on learning. When the workshop's over, participants can go home and apply the methods.

"Our goal is to get the message out and have those people in the workshops tell other people," he said. "It's not hard to be water wise, it just takes a little bit of education."

Water agencies meet, discuss selfsufficiency

Created: 02/08/2010 10:31:50 PM PST ONTARIO - With dwindling water supplies, agencies throughout California are grappling with how to survive under the current drought conditions.

Regional water experts convened Monday to discuss options to be more self-sufficient, such as groundwater, recycling and conservation.

"I don't know if there is one solution to selfsufficiency. There is no silver bullet, but you and your water agencies will have to figure out yourself," Chino Basin Watermaster CEO Ken Manning said to the others in attendance.

An issue of concern to many water agencies was "fixing the Delta" or paying for infrastructure investments needed in the Sacramento-San Joaquin Delta. A judge has halted much of the water pumping there to protect the tiny delta smelt fish.

A \$11.1 billion bond has been created to overhaul the state's water system and will be on the ballot in November.


"The whole idea on the bond and selling an \$11 billion bond in this environment is not going to be easy," Manning said.

If passed by voters, the Safe, Clean and Reliable Drinking Water Supply Act of 2010 would pay for new dams, groundwater cleanup, conservation and habitat restoration. A significant component of the bond is dedicating \$2.25 billion in funding to Delta sustainability.

The court order has already affected many water agencies, which have had their rates increased by their major supplier, said Chris Frahm, a San Diego-based attorney who lobbies for the California Groundwater Coalition, which represents groundwater managers from agencies across the state.

In some cases, farmers could no longer afford to water their crops and orchards, Frahm said. This has resulted in lost jobs, she said.

The bond has received support from several state water agencies but has been opposed by other groups, including the Planning and Conservation League, Frahm said.

The bond, because of its environmental impacts and the current economy, will be hotly contested, Frahm said.

If it does not pass, Frahm said she believes the bond will not go away.

The water conference was organized by the Association of Ground Water Agencies and the American Ground Water Trust.
