WHEREAS, membership in ACWA includes membership in the National Water Resources Association (NWRA), which assists in Chino Basin Watermaster's work toward the development, protection and management of water resources at the federal level, and

WHEREAS, Robert Neufeld has served as Chairman of the Chino Basin Watermaster Board since 1998, on the Board of Directors of the Cucamonga County Water District since 1981, on various committees and in various organizations/associations directly involved with water issues and serving the community. 


